INVITATION FOR OPEN TENDER

Odisha Forestry Sector Development Society(OFSDS) under Administrative control of Forest & Environment Department, Govt. of Odisha is organizing NATIONAL/ STATE LEVEL CONFERENCES OR WORKSHOPS INCLUDING ANNUAL REVIEW CONFERENCE 'SAMEEKSHYA'. In line of such events, the Annual Strategy Planning & Review Workshop-'SAMEEKSHYA' 2019-20 are to be organised in Bhubaneswar.

OFSDS wishes to take the services of an EVENT MANAGEMENT AGENCY (EMA) on Turn Key Basis through Open Tender for CONCEPTUALISING, DESIGNING, FABRICATION AND BRANDING OF DAIS, REGISTRATION COUNTER, PHOTO EXHIBITION PANNELS & EXHIBITION STALLS OF ODISHA FORESTRY SECTOR DEVELOPMENT SOCIETY ON TURN KEY BASIS FOR NATIONAL/ STATE LEVEL CONFERENCES OR WORKSHOPS INCLUDING ANNUAL REVIEW CONFERENCE 'SAMEEKSHYA'. The EMA shall be required to develop concept, design, fabricate, branding & manage the dais, display and entire exhibition area including Stalls ON TURN KEY BASIS in the space. The EMA is required to give Ethnic Look to the Decoration matching theme. The scope of work is enclosed as Annexure - I. The estimated cost is Rs. 3.00 lakhs excluding GST. Detailed terms and conditions are prescribed in the Tender Document, which can be downloaded from the website — "www.ofsdp.org". The bidder can approach OFSDS for any clarification with regard to submitting its bid by 19.02.2020 at 4.00 p.m. at PMU, OFSDS.

Bidder has to submit hard bound document duly numbered. The Tender should be submitted in the following manner:

The *First Envelope* labelled "Fee" should contain the Bid Processing Fee of Rs.500/- (Non Refundable) & EMD (Refundable) of Rs.5000/- in form of Demand Drafts drawn in favour of "PROJECT DIRECTOR OFSDP PHASE-II" payable at Bhubaneswar from any Nationalised Bank.

The **Second Envelope** labelled "Technical Bid" should contain the Technical Bid in sealed envelope complete with Concept & Design of the proposed Exhibition Site with Stalls, Proposed Design of the Dais for approval by competent authority, Branding & Design of all material to be put up as per the scope of work, Copy of Work Orders bringing out their Relevant Experience of the Agency in organizing similar Events, Experience of working with at least one PSU/Govt. during last 3 years, Photographs of the Events organised by them as proof. **There should be no mention of the prices in the Technical Bid Document.** Original printed document with signature & seal of the submitting company shall be considered as authentic. **Filling up prices in Annexure – IV will disqualify the Bidder.**

The *Third Envelope* "Financial Bid" should contain the Financial Bid only. Services offered should be strictly as per specifications mentioned in the Scope of work.

The first, second and third envelopes should be enclosed in a larger envelope labelled TENDER DOCUMENT FOR EVENT MANGEMENT AGENCY (EMA) duly sealed. All pages of the offer must be signed & sealed. The bids complete in all respect must be submitted through Speed Post/ Courier or by hand by depositing in the Tender Box kept at the reception in the corporate office of OFSDS as per scheduled date and time.

A Pre-bid meeting will be organized on 19.02.2020 at 4.00 p.m. at PMU, OFSDS. Duly Authorized representatives of the bidders are invited to attend the pre-bid meeting. The technical bids will be opened on 25.02.2020 at 4.00 p.m. and securitized with regard to the

eligibility criteria as mentioned in the "Scope of Work". Bidders who meet the qualification criteria will be called "Technically Eligible bidder" and they will be invited for making presentation on 26.02.2020 at 11:00 A.M. before Tender Evaluation Committee/ Expert. Thereafter, their Financial Bids will be opened on 26.02.2020 at 12:30 p.m.. Representatives of such Technically Eligible bidders will be invited to attend the Financial Bid opening meeting. The work will be awarded to the bidder who have quoted the Lowest Price bid. The OFSDS reserves the right to reject the tenders without assigning any reasons thereof.

OBLIGATIONS OF OFSDS

- 1. OFSDS shall appoint a team of OFSDS officers to evaluate the execution of work as per the Scope of Work.
- 2. Material required for the work and covered in the Scope of Work will be provided to the Selected Tenderer.

ELIGIBILITY CRITERIA:

- a) The EMA should have a minimum experience of 3 years in organizing/ managing of event in Government sectors/PSUs.
- b) Relevant experience of organizing at least two similar Exhibition/ Conferences/Festival/IEC Project activities during last 2 years (with Govt./PSU's). Duly certified copies of this experience to be enclosed.
- c) At least 2 similar assignments executed with value of more than Rs. 5.00 lakh in similar projects for PSU/Govt. bodies during last three years.
- d) Financial turnover of the company should not be less than 6 lakhs INR each during last three financial years. Chartered Accountant Certificate along with complete financial statements to be submitted.
- e) Proposed approach, Themes, Concepts in the form of a presentation elaborating execution details for the project to be assessed on resource deployment, quality, content, photographs of previous projects, relevance of presentation, creative approach, visual appeal etc.
- f) Bidder has to submit details of 5 Nos. of their best projects managed with details such as countersigned and sealed work order, invoices, completion certificate, photographs, etc.

Other Terms & Conditions

- 1. OFSDS reserves the right not to accept bid(s) from agency (ies) resorting to unethical practices or on whom investigation/enquiry proceedings have been initiated by Government investigating Agencies/Vigilance Cell.
- 2. The OFSDS is not bound to accept the lowest bidder or to assign any reason for non-acceptance. The OFSDS reserves its right to accept the bid in part or in full. Conditional bids will be rejected outright.
- 3. The OFSDS reserves the right to summarily reject an offer received from any agency (ies), without any intimation to the bidder(s).
- 4. The OFSDS reserves the right to withdraw/cancel the Bid /Tender at any stage.
- 5. OFSDS reserves the right to reduce/increase the design/design elements or alter the design/design elements and decision of OFSDS in respect of this would be final and binding on the selected bidder. As the work is on Turn Key basis thus No Extra Payment will be made for additional items required during the course of the event.
- 6. OFSDS has the right to deduct the price for short items used in variation to the scope of work of the tender and final bidding to the tenderer.
- 7. Termination by default

OFSDS reserves the right to accept or reject any proposal, and to annual the bidding process and reject all proposals at any time prior to award of contract, without thereby incurring any liability to affected bidder(s) or any obligation to inform the affected bidder(s) of the grounds for OFSDS's action.

8. Arbitration

In case of any dispute the decision of Project Director, OFSDS would be final and binding on both the parties. The jurisdiction of the court would be Bhubaneswar.

9. Indemnification Clause

"That the selected agency shall keep OFSDS indemnified and harmless against all claims, damages, dues, payments, fines, penalties, compensations, liabilities other losses etc. which may incur on account of non-compliance or violation by the selected agency or otherwise.

10. Jurisdiction

The contract shall be governed by laws of India and all Government rules.

11. Performance Security

The successful agency shall have to deposit an amount of Rs. 5000/- as performance security in the form of Demand Draft in favour of "PROJECT DIRECTOR OFSDP PHASE-II" payable at Bhubaneswar from any Nationalised Bank and the same shall be refundable after successful completion of the event.

12. Taxes

- a. Tax deduction at Source will be made as per the provisions of Income Tax Act, 1961 and GST.
- b. The Rates to be mentioned in the Financial Bid are excluding all taxes with a separate mention of Taxes to be paid.

13. Terms of payment

- (a) 50% on award of Contract after funrnishing of the Bank Guarentee of equal amount by the EMA.
- (b) Balance 50% after successful execution of the work against submission of the bill.

14. Force Majeure

Definition: For the purpose of this contract "Force Majeure" means an event which is beyond the reasonable control of a party, and which makes a party's performance of its obligations under the contract impossible or so impractical as to be considered impossible under the circumstances.

- 15. Breach of Contract: The failure of the agency to fulfil any of its obligations under the contract shall not be considered to be a breach of or default under this Contract in so far as such inability arises from an event of Force Majeure, provided that the agency affected by such an event (a) has taken all precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of the contract, and (b) has informed the other party as soon as possible about the occurrence of such an event.
- 16. Submission of bills: Within 15 days of the completion of the event.
