PROCEEDINGS OF THE 10TH MEETING OF HIGH POWER COMMITTEE OF ODISHA FORESTRY SECTOR DEVELOPMENT SOCIETY HELD ON 11TH MARCH, 2015 AT 04.00 P.M. IN THE 2ND FLOOR CONFERENCE HALL OF SECRETARIAT, ODISHA

The 10th meeting of the High Power Committee (HPC) of the Odisha Forestry Sector Development Society (OFSDS) was held under the chairmanship of Shri Gokul Chandra Pati, IAS, Chief Secretary, Odisha and President, OFSDS on the 11th March, 2015 at 12.30 PM. The list of members present is at Annexure-'A'.

2. The proceedings of 9th meeting of the High Power Committee held on 20th June 2014 which was communicated to all members vide PMU letter no. 1978/OFSDP-110 (Vol. IV)/2007 dated 25.06.2014 was confirmed by the Committee.

3. The Project Director, Odisha Forestry Sector Development Project and Member Secretary of the High Power Committee initiated the discussions. A detailed power point presentation covering the progress of implementation of the project activities and the Agenda items was made.

The HPC took note of the following progress of implementation the project and the expenditure during the year 2014-15:-

(a) Project Director, OFSDP informed the committee that the project has, so far utilized Rs.6944.95 millions in the project up to February 2015, out of which Rs. 588.48 million is eligible and has been claimed for reimbursement from JICA. JICA's total reimbursement up to December 2015 is JPY 11,710 million (5728.3 million) against the sanctioned loan of JPY 13,937 million.



- (b) Chief Secretary observed that the evaluation studies conducted by the Central Soil and Water Conservation and Research and Training Institute (CSWCRTI), Research Centre, Sunabeda has indicated that the run off rate and the soil loss was minimum in case of ANR with Gap plantation module followed by NTFP plantation module. He emphasized the need to bring more degraded forest areas under ANR with Gap plantation so as to protect the area, especially in the catchments and to conserve the soil and moisture regime of such areas.
- (c) While reviewing the progress of teak plantations in the forest areas under OFSDP, the Chief Secretary suggested that the Forest Department should work out a strategy for long term maintenance of teak plantations and engage suitable reputed research organizations for monitoring of the overall growth and to assess the volume addition.

4. The High Power Committee was apprised that the Governing Body of OFSDS in its 20^{th} meeting held on 31.01.2015 has taken following decisions in respect of OFSDP –

- a. Continuance of the officers and contractual staff of the PMU of Odisha Forestry Sector Development Project and 14 DMUs engaged under the OFSDP up to 31st March, 2016.
- b. Expenditure on account of salary of officers and contractual staff of the Project Management Unit (PMU) and contractual staff of the Divisional Management Units (DMUs) up to 31st March 2016 along with the administrative costs for the project activities will be met out of the interest accrued during project period.

- c. The cost of maintenance of plantations raised under the project and the incentives admissible to the farmers under Farm Forestry component after phasing out of OFSDP shall also be met out of the interest accrued during the project period.
- d. The proposal for creation of the IGA Resource Agency (IGRA) with experts of appropriate experience at village, cluster, DMU and PMU levels with a total outlay of Rs.4.00 crore for two years in the post project phase, i.e up to 31st March, 2017. It was decided that the Rs.4.00 crore will be from the budget allocation for the financial year 2014-15 and would be transferred to the Odisha Forestry Sector Development Society to be spent exclusively for the above purpose.

The High Power Committee ratified all the above decisions of the Governing Body as such.

5. It was informed to the High Power Committee that on the basis of decision of the Governing Body the Annual Action Plan of OFSDP for 2015-16 has been prepared involving a total requirement of Rs. 109.80 million, which includes Rs.41.19 million towards maintenance cost of plantations raised during the project period and Rs. 68.61 million towards the administrative cost. The break of proposed budget is as under:-

After detailed discussions, the High Power Committee approved the Annual Action Plan and Budget Estimate of Rs.109.80 million for the maintenance cost of plantations, towards payment of incentive to farmers and the administrative cost of OFSDP for the financial year 2015-16.

6. The High Power Committee was informed that the Annual Action Plan for Ama Jangala Yojana, which is being implemented by Government of Odisha through the Odisha Forestry Sector Development Society, was approved for implementation during 2014-15 subject to release of funds by CAMPA and NRLM. The revised Ama Jangala Yojana scheme was deliberated in the 20th Governing Body meeting of OFSDS held on 30.01.2015. The following decisions were taken –

a. The Governing Body approved the revised AJY scheme.

- b. The Governing Body resolved to authorize the Project Director for opening of separate Bank Accounts in any Nationalized Bank for funds received under CAMPA, State Plan and NRLM for implementation of AJY.
- c. The Organogram of the Community Forest Protection and Management Program Cell (CFPMP Cell) was approved by the Governing Body.
- d. The Governing Body authorized the Project Director to prepare and pose the Annual Plan of Operation to the respective funding Agencies, i.e., CAMPA, State Plan and NRLM as and when required.

The High Power Committee ratified the above decisions of the Governing Body of OFSDS in respect of Ama Jangala Yojana and approved the Annual Plan of operation in respect of this scheme at a cost of Rs.370.33 Crore, out of the funds from State Plan (Rs.13.97 Crore), interest money available with the OFSDP (Rs.4.00 Crore) and CAMPA (Rs.18.62 Crore) for tackling 1750 VSSs during 2015-16 with the following financial arrangements

It was further decided that the differential requirement for implementation of Ama Jangala Yojana will be met from the interest accrued from the above deposits and savings in OFSDP. The detailed accounting procedure will be decided by the Project Director, OFSDP.

7. The High Power Committee was informed that the decisions of the Governing Body of OFSDP meeting held on 31.01.2015 in respect of Catchment Area Treatment Plan (CATP) scheme has been placed in the 3rd meeting of the High Power Committee on Catchment Area Treatment Plan held before this meeting. The Chairman of High Power Committee observed that since the decisions have already

been taken by the HPC on CATP the same will stand as such. Accordingly, the Annual Plan for implementation of Catchment Area Treatment Plan scheme for 2015-16 along with budget provision was approved as under:-
