- As per components of Scope of Work and Technical Bid mentioned in the Tender Document are same. PMU will assess the inputs against the given components only.
- 3. As per **Scope of Work, item no 7** in the general description of Scope of Work regarding Stage Facia, and item no 8 regarding Backdrop, the size is generic and the LED screen input is optional for consideration.
- 4. As per **Scope of Work, item no 4** in Lighting segment is repetition. No inputs required on this.
- 5. As per **Scope of Work, item no 1** in Exhibition Area segment, Stall numbers required are 6 as mentioned in the quantity.
- As per the clarity on Eligibility Criteria, agencies are required to submit their Audited Balance Sheet as mentioned in Clause D. Income Tax return in lieu of this is not acceptable.
- 7. As per the clarity on **Eligibility Criteria**, agencies are required to submit any of the documents viz. completion certificates, work orders or invoices as mentioned in Clause F.
- 8. As per the clarity on **Eligibility Criteria**, agencies with similar assignments of approximate value of 5 lakh rupees would be considered as mentioned in the Clause C.
